INDEMNITY: Releasor agrees to indemnify the releases from any loss, liability, damage, or cost releases may incur due to the participation of the releasor in PROJECT 2018, WHETHER CAUSED BY THE NEGLIGENCE OF **RELEASEES OR OTHERWISE**.

Releasor expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that if any portion of this agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

This release contains the entire agreement between the releasor and releases and the terms of this agreement are contractual and not a mere recital.
